Salvatori Terms & Conditions for suppliers providing transport services:

1. Collection and delivery times must be adhered to as financial penalties may be incurred. If you encounter any problems during loading and offloading or if there are any delays on route please contact us immediately our contact number 01227 722 247.
2. In case of a failure to collect/deliver or arrange a collection/delivery of goods in reasonable time or to adhere to agreed departure or arrival dates and times any charges levied by our customer due to delay will be forwarded to the account of the subcontractor.
3. When making a collection or delivery of goods, your company driver shall ensure that the condition of the goods and their number are correctly noted and signed for accordingly. Where appropriate seal numbers on transport units must be recorded. Driver must check that the load is secure prior to departure. If there are any discrepancies, damages or the goods are not loaded as per driver's instructions you must notify us prior to departure.
4. Original delivery documents must be supplied with your invoice including our reference number no later than 21 days after delivery date. Scanned or photocopied documents will not be accepted without previous agreement. Missing delivery documents or incorrect documents may delay the payment to you or even cause additional administration charges which will be taken from your account. Delivery documents must be clearly signed for receipt of the consignment described above at destination and on date mentioned above.
5. Payment will be effected within 45 days after receipt of invoice. Subject to provision of written account statement at the end of the month as well as POD as explained above.
6. Any demurrage charges, fuel surcharges, or other charges will not be accepted unless confirmed in writing by us.
7. All goods are carried under RHA conditions within UK, and under CMR conditions for international shipments.
8. All goods and equipment that are handed to you as a result of this order are handed to you on the sole understanding that you will indemnify us against all liability in respect of, loss, delay, destruction of or damage to the said goods and equipment.
9. When travelling in Europe please instruct your driver not to park within 100 km of Calais, because of the threat of illegal immigrants.
10. Your driver must always park in a secure guarded fenced well-lit parking area when travelling in all countries of Europe.
11. Your company must not approach directly or indirectly our customer or persons or companies relevant to our customer. Non-compliance with this rule will be deemed breach of contract and will incur heavy penalties.
12. Vehicles and equipment used by your company shall comply fully with all relevant regulations relating to the carriage of goods, in particular the (England) Road Traffic Act. Vehicles and equipment must be fit for their intended use, equipped with min, 12 ratchet straps, seal cord and full set of side boards.
13. All your company employees shall be fully trained and competent to undertake their work in a safe and proper manner. Drivers need to be equipped with full PPE (including safety boots, high-visibility jacket, helmet and safety glasses)
14. Your company agrees to deal with any claims without any undue delay.
15. We reserve the right to cancel this order with reasonable notice without any consequences.
16. Not replying to this transport order within 30 minutes implies acceptance of its terms and any other terms or conditions that your company may have will not apply to this order.
